Corrigendum

The Commission vide order dated 27.9.2016 in Petition No. 350/GT/2014 had approved the tariff of Bokaro Thermal Power Station, Unit-I to III (3 x 130 MW) for the period 2014-19 in terms of the 2014 Tariff Regulations.



- 2. It is observed that certain arithmetical / clerical error had crept in the Order dated 27.9.2016 with respect to the calculation of Receivables and Interest on Working Capital and the total of the Annual Fixed Charges allowed.
