Sub: Notice Inviting Tender for Hiring of 03 Nos. (One Colour and Two Black & White) Canon Make Multifunctional Photocopier Machines in the Office Premises of CERC

Central Electricity Regulatory Commission, a statutory body set up under an Act of Parliament, invites sealed quotations for hiring of 03 (Three) Nos. (one colour & two black & white) canon make multifunctional photocopier machines on rental basis in the office premises of CERC.

The details of machine required are as under:-

Description of Work

- 3. The photocopier machines to be supplied shall be **brand new** and it will be the responsibility of the bidder to install these machines in the office premises of CERC as per the direction of Assistant Secretary (P&A), CERC.
- 4. The bidder shall be responsible for all preventive maintenance of these photocopier machines and fault rectifications. The bidder shall be responsible for providing all spare parts, drum, toner, visiting charges and other consumables etc. Photocopy paper will be provided by CERC.
- 5. The bidder shall provide standby toner/cartridge for each photocopier machine. When the standby toner/cartridge is used, a new toner/cartridge shall be provided by the bidder within 02 days.
- 6. The agency shall be responsible for the maintenance towards routine servicing and labour for attending any number of breakdown calls during the contract period and fault rectification on-site as well as off-site.
- 7. On receipt of a break down complaint, a qualified staff would be deputed immediately on the same day and fault would be rectified immediately on priority basis and within 24 hrs so as to ensure that machines are functioning satisfactorily.

- 8. The rectification works of photocopier machines will have to be carried out at the location of the equipment except in exceptional circumstances where the equipment or any component may be required to be taken out for repairs in workshop. In such case, the standby arrangement shall have to be made by the agency and in no way the working of system shall be held up for want of any standby arrangements.
- 9. The bidder must be an authorized distributor/ dealer/ reseller/ partner of the OEM. Supporting documents in this respect shall be submitted by the bidder alongwith the bids.
- 10. The bidder shall quote rate for monthly rental with 10,000 free copies along with rates of additional pages (per page) for each black & white photocopier machines and monthly rental with 2,000 free copies along with rate of additional pages (per page) for each coloured photocopier machine.
- 11. **TOOLS and EQUIPMENTS:** The agency shall arrange at its own expenses all necessary tools, equipments and parts required for proper functioning of the machines.
- 12. **TENURE OF CONTRACT:** The tenure of the contract shall ordinarily be one year. However, the competent authority in CERC, may at the discretion, allow extension of the tenure of contract, up to two spells of one year each subject to satisfactory services of the firm.
- 13. The competent authority reserves the right to terminate the contract at any time before completion of the tenure in case the services of the firm are found unsatisfactory or otherwise.
- 14. If at any time during the currency of the contract, either party wants to end the contract, a prior intimation of atleast 03 months shall be given to the other party.
- 15 **Payment Terms:** The payment shall be released on monthly basis on receipt of bill along with call log report/counter report/system manager data list, as per actual reading of the machines at the contracted rates. No advance payment shall be made.
- 16. **Mode of payment:** The payment shall be released through NEFT/RTGS on monthly basis on receipt of bill along with call reports/current report/meter reading of the machines.
- 17. **Penalty Clauses**: In case of failure of the vendor to repair the machine within 48 hrs, a recovery at the rate of Rs. 300/- per day for the down time days would be made from the bills of the vendor. In case the machine is down consecutive for a period more than 07 days in a month, a recovery at the rate of Rs. 500/- per day for the down time days would be made.
- 18. **SATISFACTORY SERVICES** The decisions of Assistant Secretary (P&A), CERC shall be final and binding on the firm / agency for the purpose of determining satisfactory services.

- 19. If additional requirement arises for similar machines during the currency of the contract, then the bidder shall provide such additional machines at the same rates and terms and conditions for the contract period.
 - 20. **PROHIBITION OF SUB CONTRACT -** The firm / agency shall not appoint any sub-contract for this work under any circumstances.
 - 21. **DEDUCTION OF INCOME TAX AT SOURCE - Since it is a "Works Job** Order", Income Tax shall be deducted as source from all the accepted payment to be made, in accordance with the provision of Income Tax Act, 1961 as amended from time to time.
 - 22. RESOLUTION OF DISPUTE - In case of dispute the decisions of Secretary, CERC shall be final.
 - 23. Quotations strictly as per the above specification may kindly be sent to the undersigned in sealed cover on or before Friday, the 27th Sep 2019 up to 3.00 P.M.
 - 24. The Secretary, CERC reserves the right to accept or reject any or all the quotations without assigning any reason whatsoever.
