With reference to your petition mentioned above, I am directed to request you to furnish the following information under Regulation 87(2) of the Central Electricity Regulatory Commission(Conduct of Business) Regulations, 1999, on an affidavit, with an advance copy to the respondents/ beneficiaries, latest by 27.11.2020:-

2014-19 period

- a) Package-wise details along with reasons of the ACE claimed from COD to cutoff date and beyond the cut-off date for all the Assets.
- b) Revised Cost Estimate for Asset-IV and reasons for cost overrun for the same.
- c) Statement of IEDC discharge for all assets with details of discharge upto Scheduled COD(SCOD), from SCOD to COD, and beyond COD.
- d) Reasons for change in Capital Cost as on COD for all Assets as compared to admitted Capital Cost approved vide order dated 6.8.2019 in Petition No. 172/TT/2018.
- e) Confirm the nature of Sub-station in Asset-II, Asset-III and Asset-IV i.e. if it is a Brownfield, Greenfield or a GIS.
- f) Undertaking on affidavit giving details of actual equity infused for ACE during 2014-19 for the subject transmission assets.

g) The details of periodical IDC (interest + other financial charges) allocated to all the assets as mentioned in para 5.11 of the Petition.

2019-24 period

- h) Package-wise details along with reasons of the ACE claimed for the Combined Asset.
- i) Confirmation whether any further ACE expected beyond 2023-24 on account of undischarged liability/balance retention payment beyond claimed.

Forms

- i) Provide Form-5 for all the assets
- k) Provide Form-13 for all assets.
- 2. Confirm that the instant assets are currently in use and information in respect of decapitalization, if any.
- 3. Confirm whether all the assets under the instant Transmission Scheme have been completed and whether they are covered under the instant petition.
- 4. In case the above said information is not filed within the specified date, the petition shall be disposed on the basis of the information already on record.
