Sub: Quotation for disposal of unserviceable items

Central Electricity Regulatory Commission invites sealed quotations for disposal/sell of surplus, obsolete and unserviceable items as per Appendix of this NIT.

Qualification of Bidders:

- (i) The firm/agency desirous of participating in this tender should have its registered office in Delhi/NCR. A copy of the valid document should be attached with the quotation/Bid.
- (ii) The firm/agency must be registered with Central Pollution Control Board or State Pollution Control Boards for handling of post use electronic and electrical equipment (E-waste). Copy of registration certificate should be attached with the quotation/Bid. Bids received without copy of such valid certificate shall be rejected.
- (iii) The firm/agency must have a valid PAN Number. Copy of document should be attached with the quotation/Bid.
- (iv) The firm/agency must have a valid GST registration Number. Copy of document should be attached with the quotation/Bid.
- 2. Before quoting the rates, the bidders may inspect the items on any working day with effect from date of issue of this NIT to 10th Nov, 2020 between 14.30 PM to 16.00 PM only (excluding Saturday, Sunday and Govt. Holidays). The person visiting CERC should hold an authority letter issued by the firm. Due to precautions in the wake of COVID crisis, not more than two persons from a firm will be allowed at a particular time. It is mandatory for the person to wear face mask, gloves and take necessary precautions as notified by Govt. of India/State Govt.
- 3. Bids should be submitted by the bidders in sealed covers as per the format "Bids for purchase of surplus, obsolete and unserviceable items" should be written on the sealed covers. The bids should be accompanied with an undertaking by the bidding firm that the items bought from CERC shall be disposed off according to the prevalent laws and rules issued by Government for disposal of such items. Bids received without such undertaking shall be rejected.
- 4. The competent authority reserves the right to terminate the contract at any time before completion of the above said work without assigning any reason what so ever. The competent authority, CERC reserves the right to accept/reject and cancel any bid, amend the quantity under any lot or withdrawn any lot at any stage before or after acceptance of bid/issue of acceptance letter/sale order/delivery order/deposit of the full sale value by the bidder, without assigning any reason thereof and the value of such material, if paid for, shall be refundable. CERC shall not be responsible for damage/loss to bidders on account of such withdrawal at any stage from the sale.

5. Earnest Money Deposit:-

- 5.1. The bidder shall submit (along with the bid) an Earnest Money Deposit of Rs. 30,000/- (Rupees Thirty Thousand only) in the form of a demand draft/Bankers Cheque drawn in favour of Central Electricity Regulatory Commission, New Delhi. Such DD/Bankers Cheque shall remain valid for a period of minimum three months.
- 5.2. In case of failure to provide EMD in the form of DD/Bankers Cheque, the bid will not be considered valid.
- 5.3. EMD of unsuccessful bidder shall be returned to them at the earliest. No interest shall be payable on such refunds. The EMD deposited by the successful tenderer shall remain with the depositing Department till payment of the SD money has been made. It may be adjusted as part of the total SD money at the discretion of disposing Department.
- 5.4 The EMD deposited by the successful bidder shall remain with CERC as security deposit for the currency of contract.
- 5.5 The EMD shall be forfeited if the tenderer unilaterally withdraws, amends, impairs or derogates from his offer in any respect within the period of validity of his offer.
- 6. The successful bidder shall deposit the payment in the form of pay order/ demand draft or NEFT/RTGS in favour of "Central Electrical Regulatory Commission" payable at New Delhi within seven days of receipt of order.
- 7. Items shall be allowed to be removed from CERC only after receipt of payment. The successful bidder shall arrange to remove the items from CERC office premises at their own expenses within fifteen days from the date of payment received by CERC. The bidder will be responsible to remove all the items as per Appendix attached irrespective of its value.
- 8. Any statutory variations in the rate of taxes/duties are to be borne by the purchaser.
- 9. Applicable taxes as per Government rules, if any, on the day of removal will be charged extra and shall be paid along with/on the Sale value as per award letter.
- 10. In case of any accident or injury caused to the tenderer or his agent or workers, from the time of entry till exit, CERC will not be held responsible for the accident / injury or for any sort of compensation.
- 11. The tender submitted by the tenderer for the purchase of items shall be valid for a period of 90 days from the date of opening for finalization of sale.
- 12. **PROHIBITION OF SUB CONTRACT:-** The firm / agency shall not appoint any subcontract for this work under any circumstances.
- 13. **RESOLUTION OF DISPUTE:-** In case of dispute, the decision of Secretary, CERC shall be final.

- 14. The Secretary, CERC reserves the right to accept or reject any or all the quotations without assigning any reason whatsoever.
- 15. The Sale Order will be issued in the name of the actual tenderer as per our records and no resale of the items sold is permitted within our Office Campus.
- 16. The rates quoted by the tenderer shall be FINAL, and will be construed that the tenderers have inspected the items mentioned in the tender schedule. No dispute with regard to description, condition, quantity etc., whatsoever will be entertained at any stage after the receipt of Tender.
- 17. Quotations may be sent to the undersigned at the above address in sealed cover on or before 1500 hrs on Wednesday, the 11th Nov, 2020.
- 18. Late bids, that is, bids received after the specified date and time of receipt should not be considered.
- 19. Quotations/Bids will be opened by the Committee, CERC on the same day i.e. 11th Nov, 2020 at 1600 hours. Bidders may send their authorized representatives if they, so desire alongwith an authority letter to attend bid opening meeting.
- 20. Bids shall be evaluated on the basis of total Amount. The bidder with highest quotation would be awarded the contract. Only the successful bidder would be communicated in this respect.
