Central Electricity Regulatory Commission, a statutory body set up under an Act of Parliament, invites sealed quotations for creation of two new chambers for the use of Joint Chief level officer at 4<sup>th</sup> Floor, Chanderlok Building, Janpath, New Delhi-110001.

- 2. The detailed scope of work and quantity of materials required are given below:-
- 2.1 <u>Scope of Work</u>. The whole work is to be considered as a Turnkey project. The firm which will be awarded the contract, shall complete the whole work, the details is as under:-

Dismantling of existing 03 Partition of Durian Make, removal of debris, Creation of Two new chambers, fixing of toughened frosted glass in partition, Powder Coated Aluminum frame, Handle, Lock with all accessories, including all civil and electric work etc. for the use of Joint Chief level officers at 4<sup>th</sup> Floor, Chanderlok Building, Janpath, New Delhi-110001 including supply of required materials. The chambers to be created should be exactly like other existing chambers of Joint Chiefs.

### 3. Terms & Conditions

- 3.1 The above five named NDMC/CPWD/PWD registered Contractors shall be eligible to participate in Quotation Process.
- 3.2 The work shall be carried out as per relevant NDMC/CPWD General Specifications for Civil works etc.
- 3.3 No T & P shall be issued by the department.
- 3.4 Free water and power supply shall be supplied to the contractor by department during the above work.
- 3.5 The rates quoted shall be inclusive of all Taxes and duties, nothing extra shall be paid on this Account.
- 3.6 The contractor shall be responsible for engagement of labour keeping in view the work, site and time period for completion of work assigned.
- 3.7 Any damage to the existing fittings shall be replaced by the contractor at his own cost and risk, to the entire satisfaction of the Assistant Secretary (P&A), CERC.
- 3.8 Increase/decrease in the size/qty of chambers, if any, be paid/adjusted on pro-rata basis at the time of releasing payment.
- 3.9 The makes of material will be as per undermentioned list of approved makes against each item of work.
- 3.10 Contractor shall be responsible for conduct of staff/workers deployed at site of work.
- 3.11 If any item is to be different than whatever mentioned in the schedule of work it should specifically be brought out to the notice of department while quoting for the tender.
- 3.12 The work is to be carried out in building having very strict regulations. The persons engaged on work must have good character antecedents. The contractor should familiarize himself with the process of obtaining entry passes/entry tokens etc.
- 3.13 No claim for wastage of labour due to non-issuance of entry token/entry passes shall be considered by the Department.
- 3.14 The agency is required to complete work within 30 days {on working days 06:30 PM onward & full day on Saturday, Sunday & closed holidays) from the date of award of contract.
- 3.15 The firm must have a valid PAN Number (self-attested copy to be attached)
- 3.16 The firm must have a valid GST Number (self-attested copy to be attached)
- 4. The bidder shall submit an undertaking in support of the claim that he/she has not been blacklisted during the last three years by any organizations/ Government Departments.
- 5. Evaluation of bid would be on the basis of lowest rate quoted.

- 6. The prices should be inclusive of cartage and transportation of goods etc. CERC will not pay any extra charges for cartage and transportation of goods. GST, if any, shall be payable extra.
- 7. Before quoting the rates, the bidders may inspect the site on any working day from **31st Dec**, **2021 to 10**<sup>th</sup> **Jan, 2022** between 10.00 AM to 13.00 Noon (Monday to Friday) only.
- 8. **TOOLS and EQUIPMENTS -** The agency shall arrange at its own expenses all necessary tools, equipment's and required parts for proper execution of the work.
- 9. **SATISFACTORY SERVICES -** The decisions of Assistant Secretary (P&A), CERC or any other officer authorized by the Secretary, CERC, shall be final and binding on the firm / agency for the purpose of determining satisfactory services.
- 10. **PROHIBITION OF SUB CONTRACT** The firm / agency shall not appoint any sub-contract for this work under any circumstances.
- 11. The payment shall be released through RTGS/NEFT after satisfactory completion of entire work. No advance payment will be made in any case.
- 12. **DEDUCTION OF INCOME TAX AT SOURCE** Since it is a "Works Job Order", Income Tax shall be deducted at source from all the accepted payment to be made, in accordance with the provision of Income Tax Act, 1961 as amended from time to time.
- 13. **RESOLUTION OF DISPUTE** In case of dispute the decisions of Secretary, CERC shall be final.
- 14. In case of any accident/misshaping/damage/injury with any labour on project site, all the responsibility shall be borne by the contractor, nothing shall be borne on the part of CERC in this regard.
- 15. **Penalty Clause**:- In case of failure on the part of agency or delay in completion of work, the CERC shall have the discretion to get it rectified/ completed from other sources at contractor's risk and cost.
- 16. Quotations strictly as per the above specification may kindly be sent to the undersigned in sealed cover on or before **the 11**th **January, 2022**, up to 15.00 hrs.
- 17. The Secretary, CERC reserves the right to accept or reject any or all the quotations without assigning any reason whatsoever.
