- 3. Based on the material available on the record, the Commission vide order dated 3.12.2024 in Petition No. 324/TL/2024, has proposed to issue a transmission licence to the applicant for establishment of the transmission scheme as noted in para 1 above.
- 4. A copy of the application, along with its annexures and enclosures, made by the applicant for the grant of an inter-State transmission licence to Beawar - Mandsaur Transmission Limited before the Commission can be accessed at the www.powergrid.in/subsidiaries or inspected by any person in the Commission's office by following the laid down procedure.
- 5. Notice is hereby given in pursuance of clause (a) of sub-section (5) of Section 15 of the Act that suggestions or objections, if any, to the Commission's proposal to grant a transmission licence to the applicant, as aforesaid, be sent to the undersigned by 13.12.2024 at the above noted address. The suggestions or objections received after the specified date shall not be considered.
- 6. The application shall be taken up for the further hearing by the Commission on 16.12.2024. Any person who files suggestions or objections may in his/her discretion attend the hearing, for which no TA/DA shall be paid by the Commission.
